

CAN TV Board Basics

Chicago Access Network Television (CAN TV) gives Chicagoans a voice on cable television by providing video training, facilities, equipment and channel time for Chicago residents and nonprofit groups. Cable channels CAN TV19, 21, 27, 36 and 42 have the potential to reach all cable television viewers in the city of Chicago. The CAN TV Board of Directors is a diverse group of Chicago residents from professional and community life.

Requirements:

There are up to 24 members of the CAN TV Board and all members are required to live within the Chicago city limits.

Board terms:

Board members serve a three-year term, which can be renewed for three more years.

Board Responsibilities:

Attend regular Board meetings four times a year, usually on the third Wednesday in March, June and September, with an annual meeting on the second Wednesday in December.

Members typically serve on one committee, Board Development, Finance, or Public & Governmental Relations. Committees meet at least quarterly or more as needed.

The CAN TV By-laws state that all Board members are required to become members at the recommended levels of Advocate (\$250) or Ally (\$100) in addition to making a meaningful personal contribution consistent with financial capabilities.

Board Role:

The Board acts as policy makers and Board members lend their expertise as volunteers in the areas of finance, legal, public relations, fundraising, community outreach, etc. Board involvement in helping diversify funding support will become increasingly more important in the future. Board members are selected who believe in the need for an active public media and who support CAN TV's first amendment mandate.

Current goals:

- 1) Maintain a continuous, predictable source of revenue that increases over time.
- 2) Build a base of non-partisan political support to help CAN TV achieve its goals.
- 3) Allocate resources to increase geographic, demographic and issue-based diversity of programming.
- 4) Improve overall operations to strengthen infrastructure.
- 5) Promote, protect, and adapt an accessible, prominent public forum to match media changes.
